



## PRIVACY POLICY

### WHAT THIS PRIVACY POLICY COVERS

Solomon Blake LLP is committed to ensuring that your privacy is protected and complies with the Data Protection Act 1998.

This policy covers the manner in which Solomon Blake LLP collects and stores the personal information of users submitted at the time of registration. This policy applies to the user's past use of Solomon Blake LLP products and services, in addition to information about the user which is personally identifiable. Such data would include the user's name, address, email address, or phone number.

### INFORMATION COLLECTION AND USE

From time to time we may ask for your personal details (such as your name, employer, position and contact details) in order to be able to provide you access to certain information on our site and to respond to you in relation to any matter you raise with us. We also use the information to monitor the usage of our site in general.

Solomon Blake LLP collects information concerning the user upon registration for services and/or information offered through Solomon Blake LLP. Further, Solomon Blake LLP collects information on the user's use of Solomon Blake LLP services and information, and the Solomon Blake LLP website.

Upon registration, the user will be asked to provide certain information, including name, email address, and trading interests.

Solomon Blake LLP automatically receives and records information from the user's browser in its server logs. Such information includes the user's IP address, cookie information, and page requests. Solomon Blake LLP uses the above identified information for the following general purposes: to customize the advertising and content shown to the user; to fulfil requests for products and services; to improve the Solomon Blake LLP offering; to contact the user; and for the collation of market information.

### INFORMATION SHARING AND DISCLOSURE

Solomon Blake LLP will never rent to, sell to, nor share personal information about the user with any third party, except to provide products or services specifically requested by the user, and with the user's express permission, except under the following circumstances:

Solomon Blake LLP will, on occasion, provide information to trusted partners who work on the behalf of or with Solomon Blake LLP under confidentiality agreements. Such companies may, from time to time, employ the user's personal information to enable Solomon Blake LLP to effectively communicate with the user about products and/or services which may be interest. At no point will said companies have any independent right to share this information;

Where required by law, Solomon Blake LLP will respond to subpoenas, court orders, and/or any legal process. Solomon Blake LLP will also adopt necessary measures to establish or exercise its legal rights, or in defense of any legal claims initiated;

Where necessary, Solomon Blake LLP will share information with relevant authorities in order to investigate, prevent, or take action against illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of Solomon Blake LLP's terms of use, or as otherwise required by law.

The transfer of user information may be necessitated following the merger or acquisition of Solomon Blake LLP with or by another company respectively. In this event, Solomon Blake LLP will advise users of such a transfer prior to the transfer of any user information. Solomon Blake LLP will also inform the user of any pertinent privacy policies subsequently governing the storage and use of their information.
